It is notified that the applications from the eligible candidates belonging to the Telangana State **who have passed Intermediate with Bi.P.C group**are invited for admissions into all two year duration Para Medical Diploma Coursesfor the AY 2018-2019in the State of Telangana. If candidates with Bi.P.C group are not available, candidates with Intermediate M.P.C group and thereafter other groups will preferred **except the DRTT Course for which Bi.P.C/M.P.C group is compulsory**.(Total Seats-33280 (i.e.) DMLT-6765, DMIT-3136, DANS-1703, DCARDIO-606, DCLT-238, DRGA-2434, DDRA-191, DECG-1668, DPERFU-197,DOA-3104, DRTT-320, DHFSM-149, DMS&OTT-2489, DAM-181, DDIALYSIS-656, DOM-1371, DREST-175, DMPHA-7760, DDHY-40, DDT-55, DMS-12, DHLST-30).

The List of Candidates Selected shall be sent by the DM&HO along with the application formstoTS Para Medical Board, Hyderabad by <u>04-08-2018</u>, failing whichit will be construed that no candidate is allotted to the Institute.

The last date for sendingthe following lists by the Paramedical Institutions to the Telangana State Para Medical Board, Hyderabadis <u>04-08-2018</u> failing which it will be construed that no Candidate is admitted by the Institute and <u>epass</u> will not be confirmed duly informing the concerned welfare departments.

- a) list of selected candidates by DM&HO under Govt. quota during counseling
- b) list of candidates selected under Management quota to TSPMB for **verification and approval** and
- c) list of candidates selected by the Institute in the left-over seats of the Govt. Quota.

2. Incomplete application or application without attested copies of relevant documents including transfer certificate will be rejected. The counseling process shall be completed by **24-07-2018** by the **Selection Committee** of the District concerned consisting of the following:

a) District Medical & Health Officer

:Chairman cum- Convener

b) Superintendent of a Teaching hospital

:Member

c) Deputy Director/ District Social Welfare Officer

: Member

d) Principal of the concerned training Institution

:Member

The Committee shall make selections in Government quota seats (i.e. 60% of the total number of sanctioned seats) purely on merit on the basis of aggregate marks obtained by the candidates in relevant group subjects excluding the marks obtained in the languages. In deciding such merit, candidates who pass under compartmental system will be placed after candidates who pass in single sitting. After the counselingprocess is completed, if any Government seats are left over, the Institutes are permitted to fill those seats automatically and the same is informed to the Telangana State Para Medical Board on or before 30-07-2018 for verification and approval.

- 3. The Committee shall **verify the period of validity of recognition granted** to the Para Medical Institutions by the Telangana StatePara Medical Board before allotting the candidates under Government Quota. The maximum number of students to be allotted in each paramedical course shall not be more than the sanctioned intake capacity.
- 4. The Managements of the Institutions shall admit the candidates allotted by the Selection Committee on the basis of ranking assigned to them against the **Government seats**.
- 5. Selection for the **Management seats** shall be made by the management only. However, the selection shall be based on objective criteria including merit in the qualifying examination. After the list of students to be admitted is made, it shall be submitted to the Telangana State Para Medical Board for its **verification and approval**.
- 6. **Rule of reservation** shall be strictly followed while making selection for both Government quota seats and management seats. If qualified candidates are not available in the category for Scheduled Tribes, the seats reserved for them shall be made available to Scheduled castes and vice-verse. If qualified candidates belonging to Scheduled Castes are not available, the left over seats reserved for them shall be treated as open competition seats and shall be filled up with the candidates of general pool.
- 7. Out of the seats available for admission, 15% for SC, 6% for ST, 25% for BC's, and for special categories(i.e. 3% horizontal reservation for Physically Handicapped in each category (OC,BC,SC,ST) for Visually handicapped/Hearing Impaired/Orthopedically Handicapped (each 1%); 1% for NCC candidates; 2% for the children of Ex-Servicemen; 1/2% (half percent) for Sports and Games candidates are reserved. 85% of the seats are reserved in favour of local candidates. The SC/ST/BC candidates should furnish the prescribed community certificate signed by the competent authority not below the rank of M.R.O.

- 8. The reservations meant for local candidates shall be followed as prescribed in the Andhra Pradesh Educational Institutions (Regulations of Admissions) Order, 1974, as amended from time to time. The candidates should be the Indian Nationals and the minimum age shall be sixteen (16) years. Migration Certificates of the students admitted from other than Telangana Stateshould be obtained; otherwise their applications shall not be entertained and accepted by the Selection Committee.
- 9. The Tuition fee prescribed per annum per each student is Rs. 13,000/- (Rupees Thirteen Thousand only) for60% Government quota seats and upto Rs 40,000/- (Rupees forty thousand only) for 40% Management seats along with other special feesas prescribed in GO Ms.No.281, HM&FW(K2) Dated 13-10-2010 or as may be enhanced by the Government from time to time.
- 10. The medium of instruction in all paramedical courses is English only. The duration of all Para Medical Diploma Courses is two years with consolidated examination in the end of AY 2019-20. The minimum educational qualification required for admissions into all Para Medical Diploma Courses is Pass in Intermediate with Bi.P.C group / if Candidates with Bi.P.C group are not available / candidates with Intermediate M.P.C group / and thereafter other groups will be preferred except for the course of DRTT for which Bi.P.C/M.P.C group is compulsory.
- 11. Minimum 75% attendance is mandatory for all the candidates which they will not be allowed to write the examinations. No condonation of shortage of attendance will be allowed.
- 12. The DM&HO concerned is requested to display the Notification on the Notice Board of his office and take necessary steps for successful completion of selections of candidates for admissions into paramedical Courses of his/her District as per Annexure for the AY 2018-19.
- 13. The DM&HO concerned is authorized to collect a sum of Rupees One Hundred only in cash for each filled-in application submitted by the candidate towards processing fee to meet the incidental expenditure.

Note: As per the information furnished by the Institutions on the status of filled-in seats for the last three years, it is observed by the Board that a huge number of seats are un-filled in a majority of Institutes. In some institutes for some courses no admissions are made for the last three years and some are not participating in the admission process at all. For the academic year 2017-18 out of the Total number of seats in all courses i.e., **32993**, **only 7109** seats filled in all courses.

In this regard the Board has decided to give as a last chance to all the institutes to participate in the admission process. The institutes who fail to participate in the admission process this year, they shall be de-recognized without any notice. The institutes who fail to get atleast 50% of the seats in any course, such course shall be de-recognized without any notice.

- D. Candidates shall not be permitted to change their social status or local candidature etc., after submission of application form.
- E. Applications unaccompanied with the required certificates or applications with incomplete entries and ineligible applications will be rejected automatically.
- F. The candidate has to pay the fee in full for the entire period of the course in-case he/she discontinue the studies in the middle and to take back the original certificates submitted at the time of admissions.
