

At the outset the Commissioner (SCDD) has welcomed all the officers and briefed the new guidelines of the Govt of India in respect of Post-matric scholarships to SC students from the year 2024-25. The Commissioner(SCDD) has also informed the officials the changes made in the ePass website under Post-matric scholarships.

It has been informed that 1,60,829 Post-matric scholarship applications have been registered in the ePass website, out of which 75,100 applications are still pending for verification in the respective college logins. The College Principal/Institution Nodal Officer, have to verify the applications online and forward the same to the District SC Development Officers through digital keys.

The Commissioner(SCDD) has reviewed the status of applications of each Education Dept and after brief discussions it has been requested to the officials of Education Dept, to take necessary immediate action on the following.

1. To ensure all the eligible SC students register their applications in ePass website. (Action Education Dept)
2. To purchase and register the Digital keys in ePass website. (Action Education Dept)
3. To forward the eligible registered applications to the District Offices. (Action Education Dept)
4. To see that all bank accounts are seeded with Aadhar. (Action Education Dept)
5. The Universities shall confirm the registered colleges in the ePass website. (Action Education Dept)
6. To address the concerned Registrars/ Principals/Head of Institutions for taking necessary action on the above points. (Action Education Dept)
7. To address all the Head of Depts of Education Dept, enclosing the status of the registrations, verifications and purchase of digital keys. (Action SCDD)

The Officers concerned were requested to take necessary immediate action on the above so as to sanction the Post-matric scholarships to SC students by the end of 15th Mar 2025, and furnish the data to Govt of India for claiming Central Assistance.
