All the regulatory authorities namely the Registrars of Universities, the Secretary, Board of Intermediate; the Director of Technical Education, the Director, School Education; Secretary, Para Medical Board, the Director, Medical Education, and all the Welfare Officers in the State of Telangana are invited to the references cited, wherein certain instructions have been issued for registration of Colleges and verification of students in e-pass system to enable process the data of students who are admitted under Convener Quota through CETS for sanction of Post Matric Scholarship.

2. The registration of Colleges and Students for the Academic Year 2025-26 in e-pass website has commenced from 01st, July,2025 and is going to ceased on 31st, March,2026.
3. The Commissioner, SCDD, TG, Hyd., has informed that so far only (9,64,243) students against (10,89,253) were registered. The registration status for 2025-2026, compared to 2024-25 is as follows:-

4. The Commissioner, SCDD, Hyderabad has therefore requested the Government to extend the last date upto 30.04.2026, so that all the eligible students and colleges are registered for the Academic Year 2025-26.

6. All the Regulatory Authorities and College Managements must ensure that all Colleges & Students who wish to register in e-pass will upload their data upto 20.04.2026, for sanction of renewal and fresh Scholarships for the Academic Year 2025-26.
7. All the students who are contemplate to get the benefit of Scholarships must visit the e-pass website at <http://telanganaepass.cgg.gov.in> and upload their data to register in e-pass website for sanction of fresh and renewal Scholarships.
8. All the Welfare Departments must give wide publicity on the Registration process for Scholarship renewal and fresh Scholarships to Students and College Managements and ensure that the registration process be completed by20.04.2026.
