ORDER:

In the G.O. first read above read with G.Os 2nd to 7th orders were issued prescribing Rules for the Andhra Pradesh Paramedical Training Institutions (Grant of permission and Regulation of admission into private Institutions) Rules, 1997.

- 2. In the letters 8th and 9th read above, the Secretary, Andhra Pradesh Paramedical Board has reported that during the 6th meeting of Andhra Pradesh. Paramedical Board held on 07.02.2011, it was resolved to request the Government to issue necessary orders converting all certificate courses to two (2) years' Diploma courses w.e.f.2011-12 academic year and furnished proposals to Government to issue orders accordingly.
- The Government after careful examination of the matter, hereby order that all the certificate courses with one year duration be converted as Diploma courses with two year duration with effect from academic year, 2012-13.
- The Secretary, Andhra Pradesh Para Medical Board and the Commissioner
 of Health and Family Welfare shall take necessary action in the matter
 accordingly.
- Accordingly, the following notification will be published in an Extraordinary issue of the Andhra Pradesh Gazettee dated 30.06.2012.

NOTIFICATION

AMENDMENT

Under the Table in clause (ii) of sub-rule (2) of rule - 6 of the said rules:-

(i) In column (2) under the heading name of Paramedical course for the words 'Certificate course' wherever it occurs 'the words 'Diploma' shall be substituted (ii) In column (3) under the heading duration of the course for the expression "1 year" wherever it occurs, the expression "2 years" shall be substituted".
