In the reference 1st cited, instructions were issued to the Secretary, A.P.Paramedical Board, to register the certificates in Public Health & Sanitation Technology of the candidates obtained from the Bethesda Institute of Health Sciences, Visakhapatnam subject to the outcome of the W.P.No.1790/2008 pending in the Hon'ble High Court in view of interim suspension of G.O.Ms.No.23, HM & FW (J2) Deptt., dated 23.1.2008.

- 2. In the reference 2nd cited, the Secretary, A.P.Para Medical Board has brought to the notice of the Government **t**hat the Bethesda Institute of Health Sciences, Visakhapatnam has not obtained recognition so far from the A.P. Para Medical Board as required under the Act (Act 38 of 2006) and that taking the advantage of the prevailing circumstances, the Institution has issued the advertisement inviting applications for admissions to the course for 2010-11 claiming that it is a Govt., recognized Institute and requested to take appropriate action against the said institution.
- 3. In the reference 3^{rd} cited, the Secretary, A.P.Para Medical Board has been requested to withdraw the Govt. Memo issued in the reference 1^{st} cited.
- 4. In the reference 4th cited, certain un-employees who obtained certificates in Public Health and Sanitation Technology from Bethesda institute of Health Sciences, Visakhapatnam have requested the Government for necessary directions to the Para Medical Board for registration of their certificates subject to the outcome of W.P.No.1790/2008.
- 5. The Secretary, A.P.Paramedical Board in his letter 5th cited has submitted that W.P.No.1790/2008 is still pending in the Hon'ble High Court of A.P. suspending the G.O.Ms.No.23 HM&FW (J2) Department dated 23.01.2008, and therefore appropriate to keep the Govt.Memo.No.4405/J2/2008-2 HM&FW (J2) Department, dated 23.04.2008 in force to avoid further legal complications till the said W.P. is disposed off finally duly cancelling the Govt., Memo 4405/J2/2008-15, HM&FW (J2) Department dated 20.8.2010.

- 6. The Government after careful examination, hereby keep the Govt.Memo 3rd cited in abeyance, subject to the outcome of the W.P.No.1790/2008 pending in the Hon'ble High Court in view of interim suspension of G.O.Ms.No.23, HM & FW (J2) Deptt., dated 23.1.2008.
- 7. The Secretary, A.P.Para Medical Board is therefore directed to take necessary action in the matter.
