Training of RMPs/PMPs – Starting of Phase-I Training Programme in 22 centers - Constitution of Committee to oversee the Training Programme and authorization to CFW to release funds towards training programme – Orders – Issued.

1. The Secretary, A.P.Para Medical Board has reported that the proposal for mainstreaming the RMPs/PMPs through a process of training has been included under DFID with others and Government have approved the MOU entered by the Commissioner of Family Welfare with HMRI. He has also reported that during the budget review meeting held on 16-6-2009, it was decided to take up a pilot programme in few centers instead of 105 centers as proposed earlier and to release the budget through the Commissioner of Family Welfare and E.O. Principal Secretary to Govt. to take up the training programme at one centre in each district (i.e. 22 centers) commencing from July,2009 to March, 2010 covering about 9,900 RMPs (22 centers x 3 batches x 3 months X 50 candidates) as follows:

Non Recurring:

(1) Infrastructure Development

0.75 Crores

(2) Content Development including training of Trainers

0.89 Crores

Recurring:

(1) Training to 9900 RMPs

2.68 Crores

Total

4.32 Crores

- 2. The Secretary, A.P.Para Medical Board has, therefore, requested the Govt. to issue orders immediately to start the Phase I programme in 22 centers i.e. one center in each District either in the District Hospital or Area Hospital, whichever is convenient to train 3 batches of RMPs/PMPs in 6 days during a week (Monday to Saturday) @ 50 per batch to enable 6 batches to undergo training during this financial year 2009-10 (before 31/03/2010) and to constitute a Committee to study and review once in a month the nature of difficulties that have been experienced and suggest the remedies to plug the loop holes in the training process to overcome such difficulties for expansion of training programme in all other centers or as many as possible in multiples in the State as a Phase-II programme and also requested to authorize the Commissioner for Family Welfare and EO Principal Secretary, HM & FW Deptt., to sanction Rs. 4.32 Crores during the financial year 2009-10 and to release Rs. 2.88 Crores immediately to HMRI under MOU already entered to enable them to start the training programme.
- 3. The Government after careful examination of the matter hereby accord permission to the Secretary, A.P.Para Medical Board to start the Phase-I programme in 22 centers in the State as proposed at para 2 above and hereby authorize the Commissioner of Family Welfare and EO Principal Secretary to Govt., HM & FW Deptt., to sanction an amount of Rs. 4.32 Crores (Rupees Four crores thirty two lakhs only) during the financial year

2009-10 and to release Rs. 2.88 Crores (Rupees Two crores eighty eight lakhs only) immediately to HMRI under MOU already entered into, to enable them to start the training programme.

- 4. Accordingly, the Government hereby constitute a Committee with the following members to study and review once in a month the nature of difficulties that have been experienced and suggest the remedies to plug the loop holes in the training process to overcome such difficulties for expansion of training programme in all other centers or as many as possible in multiples in the State as a Phase-II programme:
